- (a) All educational qualification certificates shall be from a recognized Board/University.
- (b) All experience gained shall be preferably from a Govt. Organisation and shall be counted after the date of completion of Minimum Essential Qualification.
- (c) Experience in the relevant field/area, as required for the study of the Project concerned, will be considered.
- (d) All community certificates should be issued by the authorized officers of the Govt.
- (e) The required relevant Field/Specialization may be mentioned in bracket against the position that is to be filled.
- (f) Increment @5% on initial emoluments after completion of every two years, subject to performance review.
- (g) If no suitable candidate is found for a project position, the Principal Investigator (PI) may, with the approval of the Head of the Institute and subsequent notification to the Council, downgrade the position with information to the Council.
- (h) Age relaxation upto 5 years may be granted to deserving candidates having experience of working in Government Research Organization on a case-to-case basis, by DG, ICMR/Head of the Institution. However, the contract for engagement of project staff shall be upto one year, which shall be extendable up to three-years, subject to requirement and performance review by the PI/Director (as three years is the average tenure of research projects in ICMR). In exceptional cases, extension may be granted by the Director General ICMR, up to five-years, subject to nature and requirement (s) of the project. The fixed term engagement (s) i.e. initial as well as extended, shall automatically cease/conclude, if the same is not extended within the tenure. No retrospective extension of engagement (s) shall be permissible.
- (i) Based on project requirements, the Principal Investigator (PI) may, with the approval of the Head of Institute, recruit specialized personnel with equivalent qualifications for a sanctioned position by adhering to relevant guidelines and informing the Council."

(j) In partial modification of ICMR letter dated 02-06-2023, Annexure-A para-11(b) & (c), the paid leave entitlement of 1.5 days per completed month of engagement will be calculated based on the project year and can accumulate up to the project's duration."
